


We therefore join in the following which represents our unanimous opinion and the Resolution of this City Council that:

- 1) The recommendations of the Corps of Engineers, U. S. Army, as contained in the Report issued under date of 30 October, 1961 be approved and followed.
- 2) The New Hope Dam on Haw River below the mouth of New Hope River should be constructed as soon as possible.
- 3) The construction of this dam, followed by orderly and expeditious development of the further projects called for in the plan of the Corps of Engineers will bring solid and tremendous benefits to a vast area of South-eastern North Carolina, in flood protection, water-quality control, industry, navigation, commerce and recreation.
- 4) The inconvenience, discomfort and hardship to be suffered by any persons who might be relocated due to the construction of this New Hope Dam and the other projects as recommended in the Report of the Engineers will be more than offset by the benefits accruing to hundreds of people and families in the Cape Fear Basin, including three thousand people in the Campbellton area of Fayetteville who live in an area impossible to drain because it is below the flood stage of the Cape Fear River, which fact caused the Urban Renewal Program for this area to be turned down by the United States Government.
- 5) The building of the New Hope Dam, and, in addition to the benefits listed above, would free much land in the Cape Fear River Basin to use and develop as farm land and as industrial sites which cannot now be used because of the repeated floodings of this land by the Cape Fear River.
- 6) The Congress and other related and responsible public officials should immediately and vigorously authorize, provide for and promote this New Hope Dam and the other projects recommended in the Report of the Corps of Engineers.

The above Resolution was duly passed by the City Council of the City of Fayetteville in meeting duly assembled.

Mayor Butler called the meeting to order.

City Manager Ray reported to the Council for the Airport Commission on various activities undertaken by the Commission at the Municipal Airport. He stated snack bar area of Terminal Building had been enlarged; that land had been cleared at south end of the field for flight check in connection with installation of the instrument landing system and requested approval of a contract with John Talbert and Associates, Consulting Engineers, Wilmington, N. C. for preliminary work necessary to the instrument landing system.

Upon motion by Councilman Rhodes, seconded by Councilman Plummer, the Council voted to authorize Mayor Butler to sign the contract for the city.

Upon motion by Councilman Plummer, seconded by Councilman Maness, the Council awarded a contract for the construction of a water main extension to serve Holiday Park Subdivision, Section 1, outside the city to Ray D. Lowder, Inc. the low bidder for \$35,048.44 as recommended by the Public Works Commission.

A joint meeting of the City Council and the Public Works Commission was set for Thursday, March 8, 1962 at 8:00 P.M. in the Council Room for a discussion of the new sanitary sewer rates set by the Public Works Commission and which go into effect on March 1, 1962.

Mrs. Elizabeth Ellis, the City's Fire Insurance Agent of Record was recognized by the Council and explained the Public and Institutional Plan of fire and extended coverage on city property to the Council.

After a comprehensive presentation by Mrs. Ellis and discussion by the Council; the Council, upon motion by Councilman Plummer, seconded by Councilman Rose, voted to authorize Mrs. Ellis to write the necessary policy, but to reserve actual allocation of insurance until a later meeting.

The Council, upon motion by Councilman Rose, seconded by Councilman Plummer, adopted the following ordinance regarding City Auto Tags:

THE CITY COUNCIL OF FAYETTEVILLE, N. C., DOES ORDAIN:

Section 1) Section 20-18 of the code of the City of Fayetteville, N. C., is hereby amended by adding thereto a second paragraph reading as follows:

"No owner of a motor vehicle shall display thereon a Fayetteville city license plate or tag issued for a certain calendar year, or part thereof, later in the succeeding calendar year than the last date North Carolina State license plates or tags for said certain calendar year may be lawfully displayed thereon."

Section 2) This ordinance shall be in full force and effect from and after its adoption.
