

equal rate per foot of such frontage, to be paid after completion of such work and within thirty (30) days after notice of assessment, in cash with no interest, or in five equal annual installments, bearing annual interest at six (6%) per cent, payable annually.

2) A meeting of the City Council of Fayetteville will be held at the City Hall of Fayetteville at 8:00 P.M. on the 14th day of October, 1963, on the proposed improvements when all objections to the legality of making said proposed improvements shall be made in writing, signed in person or by Attorney, and filed with the Clerk of the City of Fayetteville at or before such time, and any such objections not so made will be waived.

3) This RESOLUTION and ORDER shall be published once in the FAYETTEVILLE OBSERVER, a newspaper published in the City of Fayetteville, ten (10) days before the time fixed for said meeting.

The City Manager reported that bids had been received from three (3) firms for a crawler type tractor and a front end loader. After viewing the bid tabulation, Councilman Rhodes moved that the combination bid of E. F. Craven Company, Greensboro, North Carolina, in the amount of \$27,325.39 for both machines be accepted. Motion seconded by Councilman Packer and approved unanimously.

Upon motion by Councilman Holt, seconded by Councilman Packer, the following appointments were unanimously approved by the Council:

Upon motion by Councilman Holt, seconded by Councilman Rhodes, Council accepted the resignation of F. H. CARTER, from the POLICE DEPARTMENT.

Upon motion by Councilman Packer, seconded by Councilman Holt, a public hearing was ordered for October 14th on the annexation to the City of an area behind King Shopping Center on Bragg Blvd.

Councilman Packer moved that a public hearing be ordered for October 14th, 1963, for the proposed rezoning of a tract of land (the Luther Property) on the Raeford Road from R6 Residential to C1 Local Business District. Motion seconded by Councilman Holt and carried unanimously.

Councilman Rhodes moved for the acceptance of a petition for annexation to the City of an area on McPherson Church Road opposite Westwood Sub-division and for advertising a public hearing for October 14th, 1963. Motion seconded by Councilman Holt and approved unanimously.

Upon motion by Councilman Holt, seconded by Councilman Packer, final plat approval was given to the Joseph A. McArthur Property on the McPherson Church Road opposite the Westwood Sub-division subject to annexation to the City and subject to the approval of the City Engineer and the Public Works Commission.

Upon motion made and duly seconded, Taxicab Operator Permits were approved for the following:

Upon motion by Councilman Packer, seconded by Councilman Holt, Council followed the recommendation of Sgt. Hart, Taxicab Inspector and revoked the Taxicab Owner's Certificate of EDGAR CARL WILLIS for cause.

Council heard a request from Mr. P. O. Hoffer, Chairman of the Public Works Commission for permission for the Commission to submit a bid on the old Person Street School Property on Person Street adjacent to the present Public Works Commission yard. Councilman Rhodes moved that permission be granted. Motion seconded by Councilman Holt and carried unanimously.

City Manager Ray reported that the rental agreement between the City and Fannie Britt for the rental of a store building on the northeast corner of Person Street and North Water Street being used by the Traffic Bureau for storage would expire September 30, 1963. Mr. Ray recommended renewal of the agreement for the fiscal year 1963-1964 under the same terms. Council Packer moved that the agreement be renewed as recommended. Motion seconded by Councilman Holt and approved unanimously.

City Manager Ray reported that bids for the purchase of fire hose for the Fire Department would be received on September 26, 1963, and requested permission of the Council to accept the low bid meeting specification and place the order for same. Councilman Holt moved that the City Manager be granted such authority. Motion seconded by Councilman Rhodes and approved unanimously.

City Manager Ray reported he had received a letter from a Mr. E. L. Cunningham who requested of the City to move a house which he owns across City property - the Evans tract off Fort Bragg Road - due, as he understands, to a proposed extension of Cain Road from Bragg Blvd. across to the Morganton Road. Planning Director Rumbough stated that the Cain Road extension was one which was proposed for sometime in the future under the Major Thoroughfare Plan, but nothing definite was developed on it as yet. Following some discussion, it was suggested that the Planning Director contact Mr. Cunningham again and advise him that it would be satisfactory for him to move the house in question across City Property as long as he did no damage, but that the Council could not advise about the Cain Road extension at this time.

Upon motion by Councilman Rhodes, seconded by Councilman Packer, the following Ordinance amending a section of the City Code was adopted by unanimous vote of the Council:

AN ORDINANCE EXEMPTING NON-PROFIT
AUCTION SALES FROM CITY REGULATION *1963-14*

THE CITY COUNCIL OF THE CITY OF FAYETTEVILLE, NORTH CAROLINA, DOES ORDAIN:

Section 1. Section 8-3 of the Code of The City of Fayetteville is hereby amended by adding thereto the following sentence:

"The provisions of this chapter shall not be applicable to auction sales conducted by or under the auspices of any Church, Civic Club, or other religious or charitable organization."

Section 2. This Ordinance shall be in full force and effect from and after its adoption.

AND WHEREAS said owner(s) were thereafter notified in writing to the same effect by the City Attorney, but said owner(s) refused or neglected to do so;

AND WHEREAS said owner(s) were, thereafter, duly notified in writing to appear before the City Council at a time and place stated to give cause, if any, why said lot(s) should not be so cleared by the City and the cost of such clearing assessed against said lot(s);

AND WHEREAS, at said time and place, the City Council has duly heard and concluded said matter and now finds as fact all the foregoing and particularly that it is necessary for the public health, safety and convenience that said lot(s) be so cleared by the City;

Now, therefore, it is ordered that the City Fire Inspector cause said lot(s) to be so cleared and certify in writing to the Clerk of the City the cost of such work, whereupon, said Clerk shall transmit such certification to the Tax Collector of the City, along with a copy of this resolution, and the Tax Collector shall enter an assessment in said amount, which assessment is hereby made and ordered, against said lot(s) upon the tax books of the City, which assessment shall bear interest, be payable, and in all other respects be like, current taxes for the year in which this assessment is made.
